### **Licensing Board Defense**

A major component of Troy's case load involves defending professionals before licensing Boards in both Oregon and Washington. This includes analyzing board complaints and preparing clients for the process while developing a defense plan. His practice emphasizes handling complaints before the Washington DOH/Washington Medical Commission; Oregon Medical Board; Oregon Board of Nursing, Oregon Board of Psychology; Oregon Board of Licensed Professional Counselors and Therapists, Oregon Board of Naturopathic Medicine, Oregon Board of Licensed Massage Therapists, and the Oregon Board of Licensed Social Workers. Troy handles cases from beginning to end, including attending and defending his clients throughout both the Investigation and Administrative Hearings processes. His work also includes abuse investigations and hearings conducted through the Office of Training Investigations and Safety Overview (OTIS), in Oregon, and the DSHS/APS in Washington.

## TRIAL EXPERIENCE

**Doe v YMCA:** Marion County Circuit Court, State of Oregon: Defense verdict in \$3 million claim alleging negligence in preventing sexual assault.

**Reiker v. Kaiser:** Multnomah County Circuit Court, State of Oregon. Defense verdict in \$5+ million claim alleging a birth injury claim in failing to diagnose and properly manage shoulder dystocia during birth.

**Ellis v The Corvallis Clinic:** Benton County Circuit Court, State of Oregon. Defense verdict in \$3 million wrongful death case alleging failure to diagnose and treat lung cancer.

**Williams v. Friedman, MD:** Multnomah County Circuit Court, State of Oregon: Defense verdict in \$2.5 million dollar claim alleging negligent surgical care during plaintiff's emergency appendectomy.

**Tran v. Portland Surgical Onc., PC:** Multnomah County Circuit Court, State of Oregon: Defense verdict in \$1 million dollar claim alleging negligent surgical care during plaintiff's emergency cholecystectomy.

**Sallee v. NWP:** Multnomah County Circuit Court, State of Oregon: Defense verdict in \$1.5 million dollar lawsuit alleging negligent sciatic nerve injury during the performance of a total hip replacement.

**Ramseyer v. Silverton Hospital et al.:** Marion County Circuit Court, State of Oregon: Case abandoned and dismissed with prejudice by plaintiff mid-trial in \$40 million dollar birth injury claim alleging failure to perform a timely cesarean section and perform appropriate neonatal resuscitation resulting in cerebral palsy.

**Cloninger v Radiology Specialists of the NW:** Multnomah County Circuit Court, State of Oregon: Defense verdict in \$12 million dollar claim alleging failure to diagnose an expanding spinal hematoma, leading to paralysis.

**Boles v. Jett:** Jackson County Circuit Court, State of Oregon. Defense verdict in \$20 million dollar neonatal birth injury claim alleging failure to treat staph aureus infection in premature infant.

**Mann v. Popp:** Multnomah County Circuit Court, State of Oregon.  
Defense verdict in \$1.7 million dollar defamation claim against the Romanian Pentecostal Church.

**Steuve v. Foley, MD:** Benton County Circuit Court, State of Oregon. Defense verdict in \$2 million dollar claim alleging inappropriate medication prescription and informed consent.

**Rieker v. Kaiser Foundation Health Plan:** Multnomah County Circuit Court, State of Oregon. Defense verdict in multimillion dollar fetal injury case alleging improperly handled obstetric management of shoulder dystocia.

**Colton v. Shay, MD:** Yamhill County Circuit Court, State of Oregon. Defense verdict in \$1.5 million dollar claim alleging failure to appropriately diagnose and treat a developing osteomyelitis.

**Miller v. Fedorov, MD:** Lane County Circuit Court, State of Oregon. Defense verdict in \$10 million dollar lawsuit alleging failure to diagnose and treat developing gangrene and sepsis resulting in a below-knee amputation.

**Fino-Morales v. Baer, MD:** Multnomah County Circuit Court, State of Oregon. Defense verdict in 4+ million dollar lawsuit alleging negligent obstetric management of shoulder dystocia, resulting in neonatal brachial plexus injury.

**Sturman v. Tomlinson, MD:** Clackamas County Circuit Court, State of Oregon. Defense verdict in \$9 million dollar lawsuit alleging negligent interpretation of prenatal fetal ultrasound resulting in the live birth of a brain damaged neonate.

**Van Dijken v. Baugh, MD:** Multnomah County Circuit Court, State of Oregon. Defense verdict in \$2+ million dollar lawsuit alleging failure to diagnose and treat developing post operative peritonitis.

**Miller v. Athey, MD:** Benton County Circuit Court, State of Oregon. Defense verdict in multimillion dollar wrongful death lawsuit alleging a failure to diagnose and treat an impending heart attack.

**Albi v. Kaiser Foundation Health Plan:** Multnomah County Circuit Court, State of Oregon. Directed verdict in multimillion dollar lawsuit alleging inappropriate management and use of prescription drug, Lupron Depot resulting in profound neurologic damage.

**Greer v. PeaceHealth:** Lane County Circuit Court, State of Oregon. Defense verdict in \$1+ million dollar claim alleging a failure to diagnose and treat infective endocarditis leading to heart valve replacement.

**Pohler v. Family Practitioner Health Clinic:** Clackamas County Circuit Court, State of Oregon. Directed verdict in case alleging failure to diagnose and appropriately treat ankle fracture, resulting in permanent injury and disability.

**Johnson-Eddy v. Northwest Permanente, PC:** Multnomah County Circuit Court, State of Oregon. Directed verdict in \$1.8 million dollar wrongful death case alleging medical negligence in prescribing narcotics resulting in accidental overdose.

**Klutschkowski v. Oregon Medical Group:** Oregon Court of Appeals, 2012. In this landmark medical malpractice case, the Oregon Court of Appeals held that a minor's noneconomic damages were capped at \$500,000 in lawsuits alleging negligent birth trauma. The court reasoned that such claims were not recognized at common law and should be, therefore, subject to damage award limitations imposed by the Oregon State Legislature. In appeal to Oregon Supreme Court, the issue of the cap applying to intra-uterine birth injury was left open, as the court held that the facts in this shoulder dystocia case did not involve an *in utero* injury.

**Skaw v. Jayaram:** Multnomah County Circuit Court, State of Oregon. Defense verdict in lawsuit alleging severe burns associated with spinal radiofrequency ablation procedure.

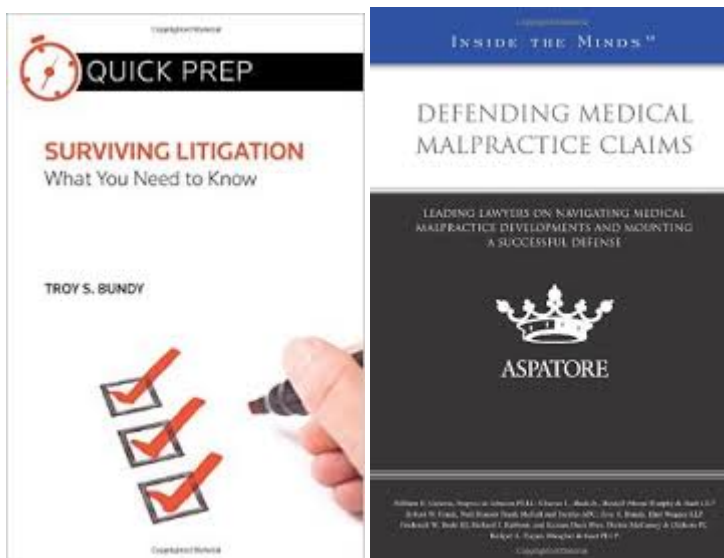
